**EXEMPTIONS**

Exemption from Parts 2 (Classification) and 3 (Documentation) of the Transportation of Dangerous Goods Regulations, as adopted by the Dangerous Goods Transportation and Handling Regulation, for the road transportation of mixed oilfield production fluids of unknown classification that may reasonably be believed to be dangerous goods in a tank designed to be loaded by vacuum with a MAWP of 172 kPa (25 psi) or greater, that is designed, constructed and maintained according to CSA B620.

**CONDITIONS**

1. The dangerous goods have not been chemically tested and classified in accordance with Part 2 of the Regulations.
2. The large means of containment or vehicles transporting the mixed oilfield production fluids shall display four placards in accordance with Part 4 of the Regulations as shown in the Appendix to Part 4 for Class 3, Flammable Liquids. The UN number shall be UN2924.
3. In addition to the permit, all consignments shall be accompanied by a document that specifies:
  - the name of the consignor and carrier

- the address of the consignor and carrier

- the words "UN2924, MIXED OILFIELD PRODUCTION FLUIDS. TREAT AS FLAMMABLE LIQUID, CORROSIVE, N.O.S., CLASS 3 (8), PACKING GROUP II - MAY RELEASE HAZARDOUS VAPOUR."

- the total quantity of the dangerous goods expressed in an appropriate unit of measurement of the International System of Units (SI) (for example, litres or kilograms) at all times.

- the date

- the 24 hour telephone number.

4. For the purposes of emergency response and reporting requirements, the large means of containment should be treated as:

"UN2924, MIXED OILFIELD PRODUCTION FLUIDS. TREAT AS FLAMMABLE LIQUID, CORROSIVE, N.O.S., CLASS 3 (8), PACKING GROUP II - MAY RELEASE HAZARDOUS VAPOUR"

5. A copy of this permit shall accompany each load and the driver shall be made aware of the permit location.
6. This permit exempts the permit holder from only those Part(s) or Section(s) of the Regulations identified above. To qualify for the exemptions shown, all permit conditions must be adhered to and all remaining applicable provisions of the Act and Regulations or other related legislation must be complied with.
7. If the conditions of this permit are not met, the permit holder shall be in full compliance with the Act and Regulations and the permit shall no longer be applicable.
8. This permit is valid only in Alberta.

9. All those involved with the handling, offering for transport, and transporting the dangerous goods identified shall be trained and certified in accordance with Part 6 of the Regulations.
